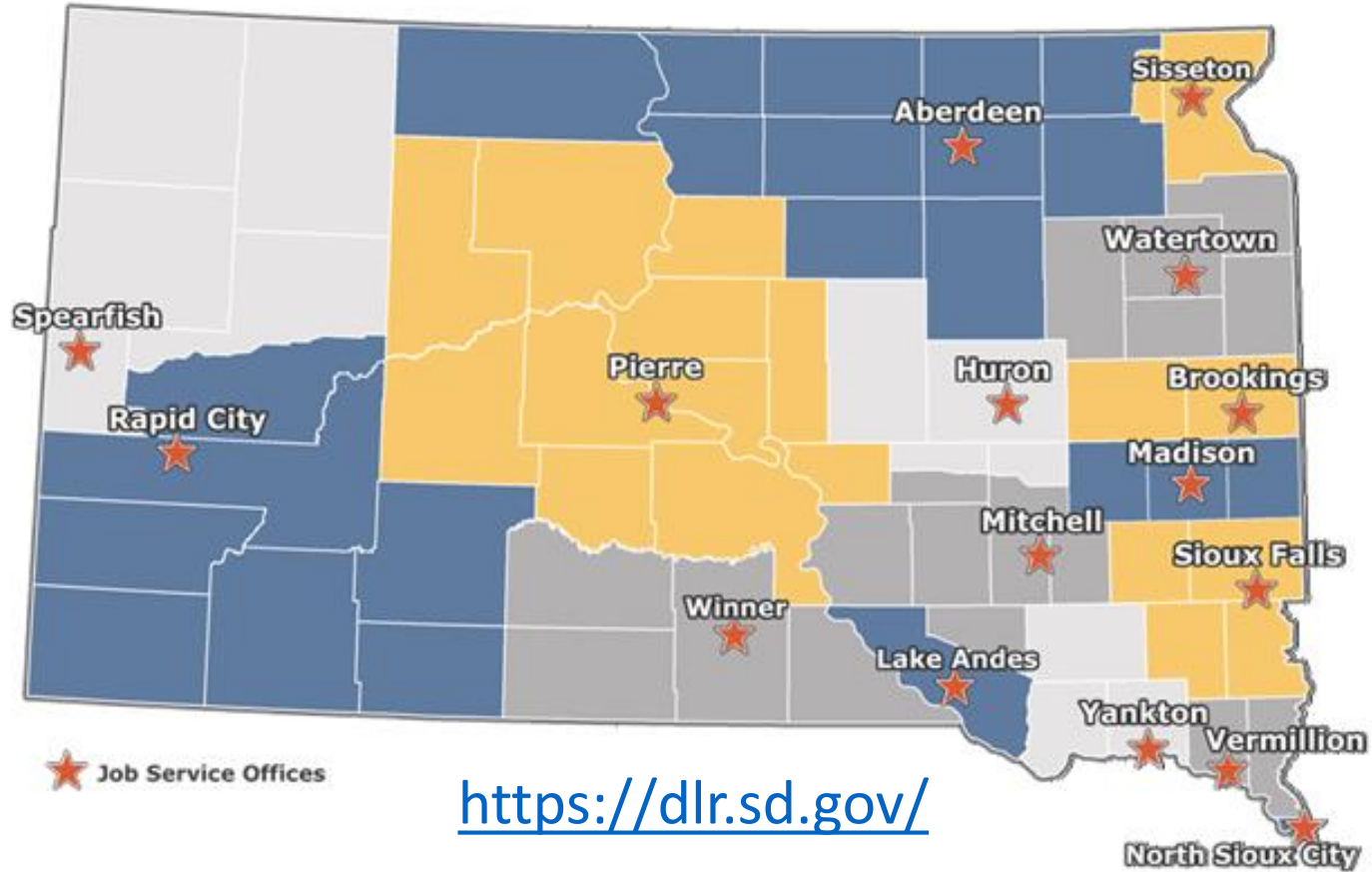


## Why Collaborate with Adult Agencies--

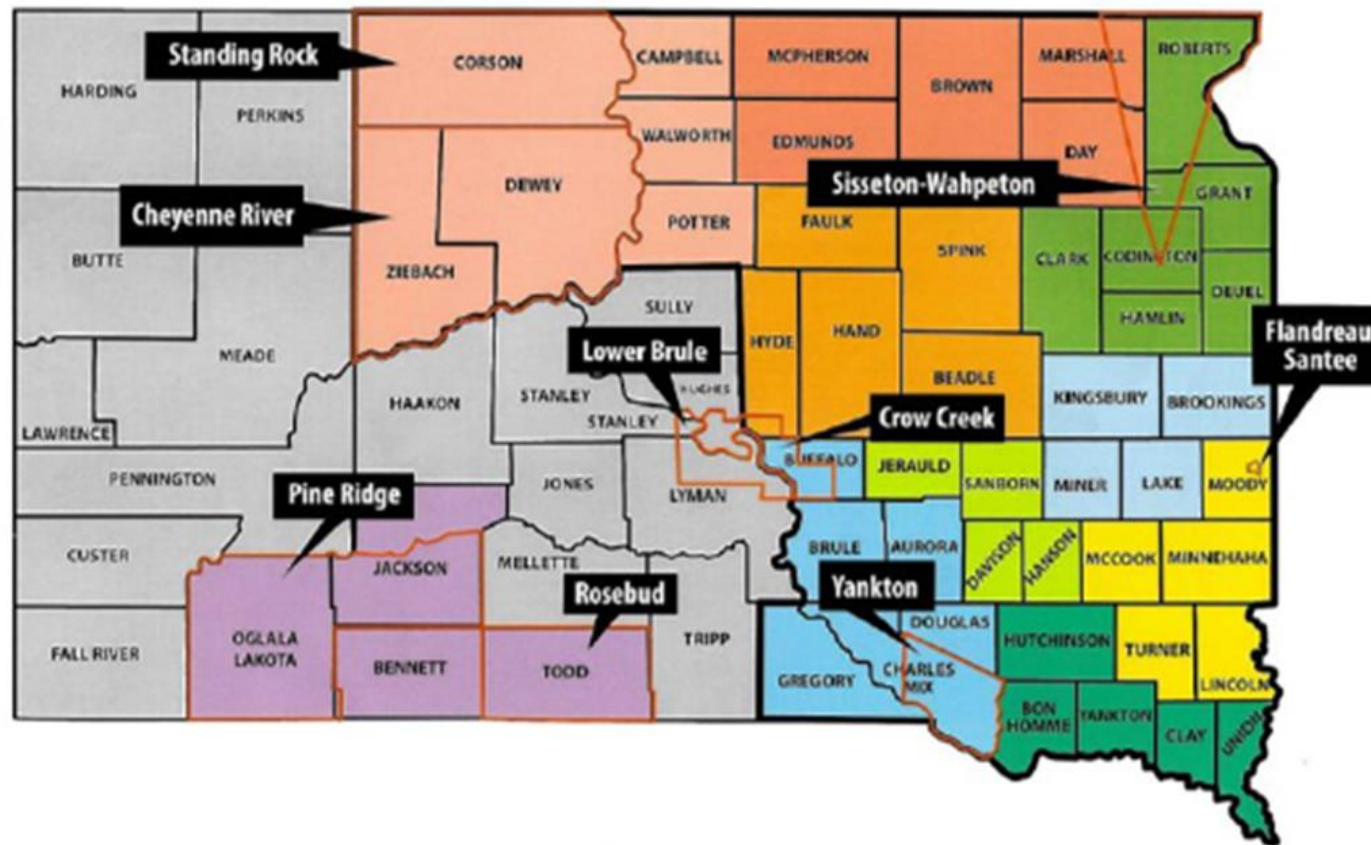

## South Dakota Adult Services/Resources

\_\_\_\_\_ **Division of Vocational Rehabilitation (DVR).** DVR funds the "Project Skills" program, a paid work experience program available for students age 16 and older who qualify. DVR assists individuals with physical or mental disabilities to obtain employment and live independently. Services may include counseling, training, job placement and more. <http://dhs.sd.gov/rehabservices>

\_\_\_\_\_ **Service to the Blind and Visually Impaired (SBVI).** Can offer services to individuals who have blindness or a visual impairment, such as adjustment to blindness training, rehabilitation counseling, assistance in finding and keeping a job, tools and supplies needed to reach goals, vocational training, post-secondary preparation, assistive technology, and more.

\_\_\_\_\_ **Social Security Administration.** Manages two different disability programs – SSDI and SSI. Both programs provide a monthly income for people with disabilities, but the rules that affect eligibility for them are different. \_\_\_\_\_ **SD Benefits Specialist Network.** Regional Benefits Specialists provide SSI and SSDI beneficiaries with access to benefits planning and assistance services. BHSSC - 224-6287

\_\_\_\_\_ **Centers for Independent Living.** Staff at several Centers located throughout the state could assist in these areas: housing, community resources, independent living skills, peer support, employment, self-advocacy, personal safety, individual rights, and attendant management. \_\_\_\_\_ **Mental Health Centers.** Provide a full range of mental health services, including emergency care, evaluations, case management, consultation, and outpatient care.

\_\_\_\_\_ **SD Parent Connection.** Connects families caring for children (birth – 26) with the full range of disabilities or special health care needs to information, training and resources in an environment of support, hope and respect. \_\_\_\_\_ **Conflict Free Case Managers.** Case management is no longer provided by local Community Support Providers, but rather from an external organization. You will have the opportunity to select your own conflict free case manager. This individual will help you coordinate services and supports from available providers & resources. <https://dhs.sd.gov/developmentaldisabilities/cfcm.aspx>

\_\_\_\_\_ **Community Support Providers.** CSP's are located throughout the state and provide day and/or residential services to individuals with developmental disabilities, primarily age 16 and older. Services include community living training, home/community based services, follow-along services, pre-vocational and vocational training. <http://dhs.sd.gov/developmentaldisabilities/csp.aspx>

\_\_\_\_\_ **Intervention & Support Specialists.** The Division of Developmental Disabilities employs statewide Intervention & Support Specialists to assist individuals with developmental disabilities and their families in accessing services

\_\_\_\_\_ **Family Support 360 Program.** Family Support 360 serves people with developmental disabilities. This program assists participants and their families in getting the services they need to live as independently as possible in the community.

\_\_\_\_\_ **Post-Secondary Schools.** Post-secondary education can be pursued through avenues such as public or private colleges, universities, community colleges, technical colleges, and business and traditional schools. \_\_\_\_\_ **National Farm Worker Jobs Program.** Assists seasonal and migrant farm/ranch workers (hired laborers) obtain permanent, full-time employment in any industry of his/her choosing (within or outside of the agricultural field). <https://bhssc.org/national-farmworker-jobs-program>

\_\_\_\_\_ **Legal Guardianship.** The S.D. Guardianship Program provides professional guardianship, conservatorship, and related protective services for adults with disabilities. \_\_\_\_\_ **Job Corps Program.** A free education and training program that helps young people learn a career, earn a high school diploma or GED, and find and keep a good job. \_\_\_\_\_ **CSD.** Serves deaf and hard-of-hearing people in South Dakota. Some services provided include interpreting, advocacy and consultation, employment services, communication equipment, independent living, mentoring and more.
